They represented 21 Countries, and of them 3 were non EU Nations (Armenia, Georgia, Turkey). The following NMAs have delegates: Austria, Georgia, Greece, Spain, The Netherlands, Turkey.

The Bureau

There was an electronic vote organized by the Coordination; Pr. Alessandra Renieri was elected as Secretary, and Serdar Ceylander as vice President. The Bureau consisted of the President, Secretary, and a vice President.

Meetings

There was no official membership meeting during the year. However, both the President and the Secretary participated at the London UEMS Council Meeting, and there was a non-official gathering of the participating MJC RUD members.

Main focus in 2019 and after

Construction of ETR of Rare and Undiagnosed Diseases, Rare Adult Solid Cancer, and the ENETS ETR.

During the year of 2019 there was still no independent budget of the MJC RUD. However, the president evaluated 5 life events for the CESMA.

Annual Report of the President – 2020

10 October, 2021

The calendar year of 2020 was the 4th full year in the history of the MJC RUD. Unfortunately, the Covid 19 pandemic strongly influenced our activity, however, we closed a quite productive year.

Membership

According to the last control, we recorded a total of 47 members from 27 Sections (OMF, IM, Ophthalmology, Paediatrics, Psychiatry, Rheumatology, Medical Genetics, Neurology, Paediatric Surgery, Pharmacology, and Rehabilitation. They represented 21 Countries, and of them 3 were non EU Nations (Armenia, Georgia, Turkey). This is an increase. The following NMAs have delegates: Austria, Georgia, Greece, Spain, The Netherlands, Turkey. However, some members indicated their resignation, indirect evidence suggest that some of the members on the list are not active. Therefore, a "housekeeping" is on the way with the assistance of Marine Boulard at the Coordination.

The Bureau

There was an electronic vote organized by the Coordination; Dr. Domenica Taruscio was elected as vice-president, and Dr. Artur Beke was elected as treasurer, the president was re-elected, all for terms started 2021 January. The Bureau consists of the president, secretary, treasurer, and 2 vice presidents.

MJC RUD Meetings

There was no official membership meeting during the year. All of our activity was conducted via emails.

Main focus in 2020 and after

Council approved the ETR of Rare and Undiagnosed Diseases (79.95 % support), Rare Adult Solid Cancer (68.42% support), and the ENETS ETR (88.89% support):

As the web was associated to the Section of Medical Genetics (SMG) as a courtesy of the provider to Dr Melegh, SMG president, this was not available after 2021 January, as the term of Dr Melegh expired.

Finances

At the moment 889.1 Euros budget of the MJC RUD is available, we already paid 300 Euros CESMA membership contribution for 2021. The president evaluated 6 life events for the CESMA. The president requested support from the UEMS Exec, unfortunately the request was rejected 3 times.

Participation in other activities

A Memorandum of Understanding (MoU) was signed with the Undiagnosed Network International (UDNI). This MoU could be a base of further strong collaboration in education fields primarily. The president participated in the work of the CESMA, and continued with the EACCME "Training the reviewers" working group.

Supplement 6.

European Board of Rare and Undiagnosed Diseases

(EBRUD)

Preface:

The main focus of the **European Union of Medical Specialists** (Union Européenne des Médecins Spécialistes – UEMS) is harmonization and improvement of the quality of medical specialist practice in the European Union, which they are trying to achieve by the formulation of a common policy in the field of medical training, continuous medical education, exchanges of trainees between Countries, manpower problems throughout Europe. The UEMS represents more than 50 medical disciplines through various bodies. A European Board as a subgroup was formed in conjunction with the relevant European Society, with the goal of defining European standards of medical education and training. They also contribute to the work of Multidisciplinary Joint Committees (MJC). The European Medical Boards have different board spectrums of goals. Common point is focus is on specific aspects of education. In general the Boards are organized under the umbrella of the UEMS and can be regarded as educational arms of the UEMS.

As the care of rare diseases are multidisciplinary several medical professions, if not all, are involved in the care, therefore, the knowledge base, including the education background should be harmonized by involvement of all medical specialists as major stakeholders in the field. The aim of these medical specialties is to improve the health of patients with rare and undiagnosed diseases and their families by promoting the highest possible standards of care. For this core activities that the EBRUD offers are education, training and certification modalities.

The objectives of EBRUD:

- Recommend the standards required for the training of specialists and the means of maintaining those standards.
- Make proposals for the quality of training and for the syllabus and examine the content and quality of training.
- Recommend the criteria to which the specialist RUD training centers should conform and also conduct site visits of institutions which have agreed to corresponding to these standards

- Make proposals for unifying the training programs to achieve specialist status.
- Ensure that the knowledge and skills of specialists are maintained and updated at regular intervals.
- Develop, with the subspecialties in a system to assess and recognize the quality of training and practice.
- Promote research relevant to rare and undiagnosed diseases.
- Facilitate the exchange and free movements of specialist trainees between training centers throughout Europe to harmonize and improve the quality of training.
- Organize and control the European Board Exam in Rare and Undiagnosed diseases
- Set and manage the CME/CPD of the European Board Diploma/Certificate holders
- Create a CME Registry system for rare disease experts
- Manage webpage of the EBRUD

Mission and Goals:

A unique feature of the EBRUD comes from the nature of the practice achieved in the past decade. Contrary to other medical disciplines, in this field further significant stakeholders are the patient advocacy groups. Therefore, the medical education and the CME/CPD have special aspects since besides the doctors involved in rare disease care, non-medical experts are also involved, with a special significance of the patient advocacy groups who should be involved in the training and patient empowerment. And, vice versa, feedback from them is crucial for continued development. Conclusively, representatives of patient advocacy groups are present. Additional unique feature is the emerging networks involved in specific aspects of rare and undiagnosed diseases, The most important are the European Reference Networks (ERN), which are also present in the EBRUD. While the ERNs are restricted to Europe, further international networks are also involved. In the field of rare and undiagnosed diseases a unique aspect is the special importance of the research, clinical, genomic, and IT. Therefore, professional societies as pillars of research are also included.
